The Jr. Bears Hockey League is for boys and girls, ages 9-17, with two separate divisions:

- **Division I is for players ages 13-17**
- **Division II is for players ages 9-12.**

Jr. Bears Hockey League meets two times a week for ten weeks.

This non-travel program meets at Jordan Valley Ice Park.

This program utilizes full-ice for practices and games.

League Fee: \$110 per division, per player
